# **Extract your publication list**

In « My DI-fusion », on the left handside of the screen, you find shortcuts to your publication lists. They are available 24/24 and include what has been entered in DI-fusion, a couple of minutes after adding, modifying or deleting references.

You can chose to export your publication lists in the following formats:

- as requested by FNRS
- · as requested by CV-ULB
- as you wish: custom list

It is possible to extract from DI-fusion a de-duplicated list of **publications for a group of persons** working at ULB. Contact <u>di-fusion@ulb.be</u>.

## **DI-fusion and Google Scholar**

Publications entered in DI-fusion are **available in Google Scholar**. It gives them more visibility and increases accessibility of the scientific research results from our university. In addition, when creating your own Google Scholar profile, you will get your own bibliometric measures (h-index, ...). ### **ULB** institutional repository policy

Any researcher having a contractual or statutory relation with Université libre de Bruxelles is requested to:

- register in DI-fusion the complete list of his/her publications to constitute the academic bibliography;
- deposit in DI-fusion, for archiving purposes, the full text of his/her publications (final author manuscript as accepted for publication – "postprint"- or publisher's PDF version) immediately upon acceptance for publication;
- open access on the internet to the publications' full text immediately or after the
  delay imposed by the publisher, considering that for any article published from
  September 14, 2018, this delay cannot exceed 6 months after publication in
  science, technology, medicine, or 12 months in the social sciences and humanities.

This Open Access policy of the University was updated by the Academic Board on July 9, 2018 and accounts for the provisions of the decree of the Wallonia-Brussels Federation "Décret visant à l'établissement d'une politique de libre accès aux publications scientifiques (open access)"

The list of publications generated by DI-fusion is the only official list at ULB and must be attached to any application.

# Why deposit your publications in DI-fusion, the ULB institutional repository?

- ✓ **Reference**: DI-fusion provides the ULB academic bibliography; it gives an overview of scientific publications by ULB researchers and is used for for research dissemination and evaluation purposes.
- ✓ **Visible and accessible**: full-text publications which are available in DI-fusion are indexed by search engines, thereby increasing their national and international impact.
- ✓ **Sustainable**: publications deposited in DI-fusion are archived and preserved whatever their file format, in a unique and lasting place.
- ✓ **Easy**: deposit your publications once, in DI-fusion, and reuse the metadata as you like thanks to the many functionalities: to feed other reference tools, include your publication list in your ULB CV, in an FNRS application or European project proposal, on your website, in an annual report, in an EQUIS assessment or for any other purpose

## Deposit in a few steps

#### 1. Authentify

Start at https://difusion.ulb.ac.be and click on « My DI-fusion »



Enter your ULBID and related password.

#### 2. Manage

Your references currently under submission

Your pending references, for which the submission process has not been completed.

Your references in DI-fusion

References of publications authored by you, which have been entered and validated in DI-fusion.

#### 3. Deposit



Select the type of document you are submitting.

**Enter the metadata** (author, title, publisher...). The entry form is adapted to the document type you have selected in order to display only the fields that are necessary.

**Deposit the full-text file(s)**. Many file formats are accepted such as PDF, Word, Powerpoint, LaTeX ...

**Select which access you want for the file**: open access [internet], restricted access [ULB Intranet], no access.

**Check the data you have entered**. When depositing file(s), you grant ULB a non exclusive license for reproduction and communication, allowing ULB to provide access to your publication in respect of your choice.

#### Who can deposit and what?

Any ULB researcher (and doctoral candidates) who has an active ULB NetID can deposit in DI-fusion. You can also choose a delegate for the deposit of your publications.

#### Am I allowed to deposit a publication on open access?

The Belgian law allows you to **RETAIN** the right to deposit

- the manuscript (preprint or postprint version) of any periodical article resulting from a research funded at least half by public funds
- freely available to the public i.e. on **open access** on the internet- after a **delay** of :
  - 12 months after publication for social sciences and humanities
  - 6 months for other sciences,
- whatever the publishing contract signed with the publisher,
- as far as the source of the first publication is mentioned,
- including articles published before the entry into force of this article of law (05-09-2018).

**Book chapter, conference paper**: deposit the pubprint version of your publication on restricted access.

**Book**: deposit the pubprint version on closed access for your personal use.
